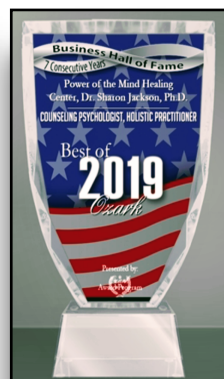

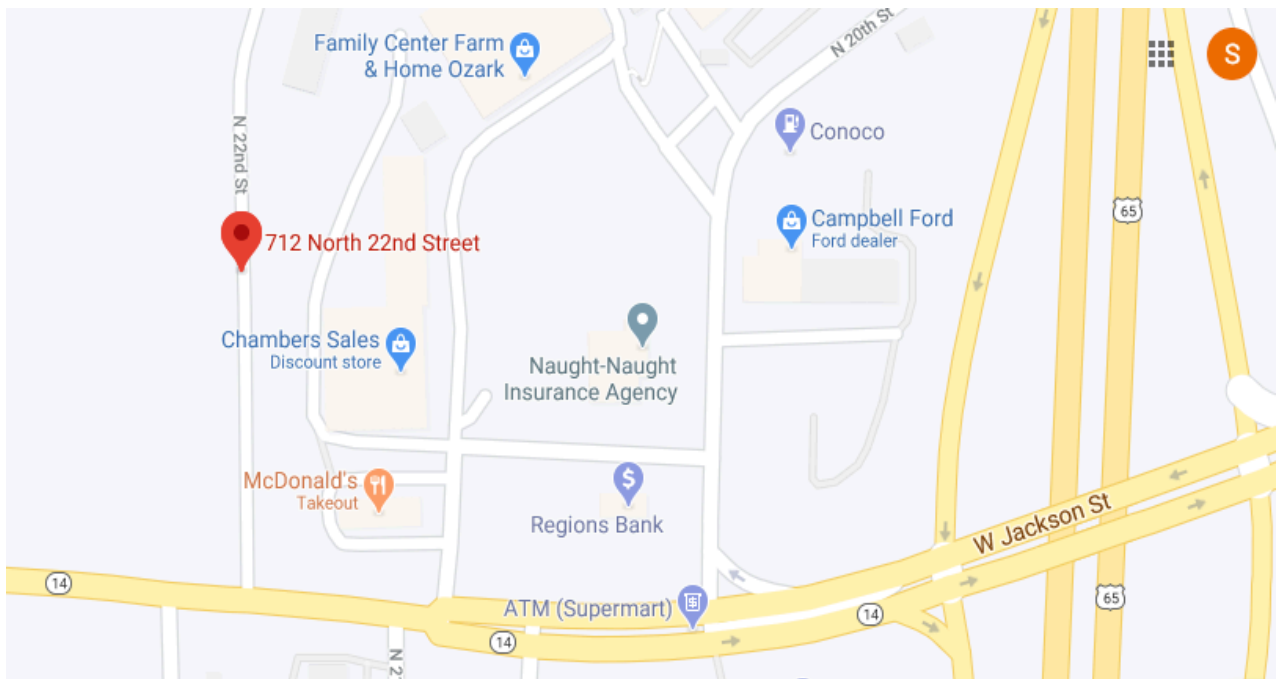

DIRECTIONS:

From Springfield take 65 South to the Jackson Street exit. Exit to the **RIGHT**. **From Branson or South**, take the same exit, but to the **LEFT**. Take Jackson West heading towards the McDonald's.
